RE: American Rescue Plan Projects

Dear Council President Rosado,

As you know, the City Council approved the American Rescue Plan Act (ARP) spending plan on May 19, 2021 and authorized my office to sign documents and enter into agreements to effectuate the terms of the spending plan. At the time of approval of the plan, the U.S. Treasury had issued tentative final guidelines for the use of those funds under the Act.

In order to ensure that the City can fully execute the plan presented and approved by the Council, I am seeking authority, as specified in the attached resolution, to allocate from Uncommitted FY'21 Budget Surplus funds that may be necessary to fund some identified projects within the specific ARP spending categories, notwithstanding that the Final Rules of Treasury might preclude such expenditures under ARP.

It is our view that the allocation plan approved by Council meets the criteria set forth in the ARP legislation. However, Treasury guidelines appear to be interpreting the legislation more narrowly. With the adoption of this Resolution, the City will have some insurance against having to forego some of our proposed efforts. This may be particularly important under the category of Economic and Community Development.

Our team is happy to answer any questions you may have. We respectfully ask Council to take action on this resolution as we are currently trying to finalize the spending plan and the allocation process. Thank you for your consideration.

WHEREAS, the US Treasury is responsible for issuing more detailed guidelines for the expenditure of ARP funding, and in so doing, appears to have more narrowly interpreted some the ARP provisions, which could impact the allocation of some funds under the approved City Allocation Plan; now therefore be it

RESOLVED, pursuant to City Charter Chap. X, Sec. 7, the Court of Common Council does hereby authorize the Mayor to expend Uncommitted FY’21 Budget Surplus, after transfers to Fund Balance and CIP/Pre-funding of school construction projects, for purposes of allocations approved in the ARP Allocation Plan, approved by the Council, if in the Mayor’s discretion there is a concern that certain projects/programs may not qualify for funding under the Final Treasury Guidelines under the American Rescue Plan Act; and be it further

RESOLVED, that the Mayor is authorized to execute any and all manner of other documents and to take such other actions as he and the Corporation Counsel may deem appropriate and in the best interest of the City, in order to expend the above referenced uncommitted surplus; and be it further

AN ORDINANCE AMENDING CHAPTER 28, ARTICLE IX, OF THE MUNICIPAL CODE OF HARTFORD TO ALIGN STANDING BUILDING COMMITTEE FOR SCHOOL BUILDING PROJECTS WITH STATE LAW – Special Act 01-7.

Be It Ordained by the Court of Common Council of the City of Hartford:

ARTICLE IX. - STANDING BUILDING COMMITTEE FOR SCHOOL BUILDING PROJECTS

Sec. 28-189. - Creation of committee; general purpose.

A standing committee (hereinafter referred to in this article as the "committee") is hereby established to serve as the building committee for all school building projects which are, or which are in the process of being, undertaken on or after October 13, 1997, other than those specific projects which constitute special school building projects as herein defined. For purposes of this article, a special school building project shall be any regional or cooperative school building project undertaken pursuant to article VIII above or any other school building project which the court of common council exempts from the provisions of this article, after a public hearing.

Sec. 28-190. - Composition of committee; terms; vacancies.

(a) The committee shall consist of [the following] seven (7) members: three (3) members of which shall be appointed by the Hartford Board of Education, three (3) [public officials as one or more of the same may be replaced pursuant to the provisions of this article: the mayor , the city manager, the Superintendent of the Hartford Public Schools, two (2)] members of which shall be appointed by the court of common council (the "council"), and one (1)[two (2)] member of which shall be chosen by a vote of the other members[s of the Hartford Board of Trustees (or any successor authority)]. The initial members appointed by [of]the council and the board of education[trustees] who are to serve on the committee shall be selected by their respective bodies within thirty (30) days of the adoption of this article.

(b) The term of office for each member shall be coincident with his or her term of by reason of which he or she has been appointed to serve on the committee. Any

member of the committee whose term thereon expires by virtue of the expiration of his or her term as a member of the council or board of trustees shall be replaced by the respective body of which he or she was a member within thirty (30) days of the expiration of his or her term of office. Otherwise, any vacancy in the membership of the committee shall be filled for the unexpired portion of the departing member's term by the city manager. Any such alternate members shall, when seated, have all the powers and duties of a member of the committee.

(c) The members of the committee shall receive no compensation for their services as such but shall be reimbursed for their necessary expenses incurred in the performance of their official duties.

Sec. 28-191. - Chair person.

(a) The [city manager] chief operating officer shall serve as the chairperson of the committee.

(b) The chairperson of the committee shall have full responsibility for determining the time, place and agenda of the committee's meetings and, subject to such procedures as are adopted pursuant to section 28-192 below, the conduct thereof; providing, however, that the committee shall meet at least once every year; and providing further, that all of such meetings shall be held in compliance with the Freedom of Information Act (G.S. § 1-21) and other applicable laws and regulations. The chairperson may designate another member of the committee to act as the chairperson in his or her absence.

Sec. 28-192. - Organization; bylaws.

Except as otherwise provided in this article, the committee may draft and adopt bylaws, elect officers and do such other things as it deems necessary in the organization and implementation of its affairs.

Sec. 28-193. - Staff support.

The city may provide staff and other indirect support to assist the committee as deemed necessary or appropriate by the city for that purpose from time to time.

Sec. 28-194. - Powers and duties of committee.

The committee shall have all of the power and responsibilities granted to, or which of necessity must be exercised by, school building committees pursuant to the Connecticut General Statutes and any regulations adopted thereunder. Without limiting the generality of the foregoing, the committee also shall have the responsibilities and authority to:

(1) Provide oversight during all phases of design development for each school

building project (including, without limitation, the development of final plans and specification and contract documents for each such project) and to make recommendations to the board of trustees regarding all of the same;

(2) Review all change orders which are proposed to be entered into in respect of any project and provide its recommendation to the chief operating officer[city manager] in respect thereof;

(3) Establish uniform standards for recurring capital expenditure items;

(4) Review and evaluate performance standards of all contractors (including but not limited to, all design and construction professionals) and subcontractors on each project;

(5) Review all deficiencies and delays which may occur in respect of any project; and

(6) Inspect all school facilities, along with appropriate staff, to determine that they have completed in accordance with the plans approved by the committee.

Sec. 28-195. - Cooperation by other city agencies and departments.

Each officer, board, commission and department of the city government shall cooperate with the committee in the performance of its duties. Without limiting the generality of the foregoing, the director of public works shall provide periodic oral and written reports to the committee relative to the progress of each school building project as and when requested by the committee. Further, no change order shall be executed by or otherwise approved on behalf of the city in respect of any school building project unless and until the committee has been given sufficient opportunity to review the same.

AN ORDINANCE AMENDING CHAPTER 2, SECTION 850 OF THE HARTFORD MUNICIPAL CODE

COURT OF COMMON COUNCIL,
CITY OF HARTFORD

June 28, 2021

Be It Ordained by the Court of Common Council of the City of Hartford:

That Chapter 2, Section 850, of the Municipal Code of the City of Hartford be amended as follows:

(A) All council and Mayor appointees and Unclassified Employees employed by the City, shall maintain a continuous residence in the City during the period of such appointment or employment. This section shall not apply to new employees or appointees during the first six (6) months of such employment or appointment. If such individual ceases to be a bona fide resident of the City once the residency has been established or fails to become a bona fide resident within six (6) months of the appointment or employment, the Council shall, by a vote of seven (7) members, send notice to the mayor that pursuant to the provisions of Chapter V, section 3(c) of the Hartford Charter, the office or position of the individual who has failed to remain a bona fide resident of Hartford shall thereupon become vacant, and such appointment or employment shall terminate.

Bona fide resident is defined as:

(1) An employee who has a Hartford mailing address. A post office address does not qualify as a bona fide Hartford address;

(2) Be a registered Hartford voter; and

(3) If the employee owns a motor vehicle, said motor vehicle must be registered in the City of Hartford.

(B) The provisions of subsection (A) above shall not apply to individuals who were employees and appointees at the time of the effective date of this section.

(C) Notwithstanding the requirements established in Section (A) above, the Mayor may request from the Court of Common Council a waiver of the bona fide residency requirement by resolution for directors of the following departments: i) Management, Budget and Grants, ii) Metro Hartford Innovation Services, iii) Emergency Services and Telecommunications, and iv) Finance, provided that (a) prior to making such a request for any individual for whom the Mayor requests a waive the residency requirement, the open position shall have been publicly posted and advertised for a period of not less than one month, (b) shall have been actively promoted on public message boards, city newsletters, city website, and social media accounts, as well as through Neighborhood Revitalization Zones, and (c) the Mayor shall interview any applicants who are Hartford residents and who have been deemed to meet the eligibility requirements for these positions prior to requesting the waiver. A resolution by the Court of Common

Council granting the waiver of the bona fide residency requirement at the request of the Mayor shall specify (a) the means by which the open position was made known to the public, and (b) the nature of the technical knowledge or specific training, experience or certification required to effectively perform the responsibilities of the position. The waiver of the requirements of Section (A) may be granted by a majority of the Council members present and voting.

(D) The maximum salary for any Department Head for whom the residency requirement is waived pursuant to subsection (C) shall be reduced by ten percent (10%) from that set forth in the applicable pay scale. The maximum salary will no longer be subject to said reduction if the Department Head ultimately establishes Hartford residency as defined in subsection (A) and provides proper notice to the Department of Human Resources and Labor Relations.

WHEREAS, The City of Hartford is a diverse, welcoming, and multicultural community; and

WHEREAS, The City of Hartford values all of the service providers and organizations that work to serve, enrich, and advocate for the immigrant and refugee communities here in our city; and

WHEREAS, The City of Hartford values the attentive work and the services performed by the City's Boards and Commissions; and

WHEREAS, The City of Hartford's Commission on Refugee and Immigrant Affairs (CRIA) released its Bi-Annual Report on the State of Refugees and Immigrants in 2019, in which it recommended that the City "Enhance networks of collaboration and communication among agencies and organizations (including faith-based and ethnic community-based organizations) providing services to immigrants and refugees through a central department or agency;" and

WHEREAS, CRIA released their follow-up Annual report in 2021, re-emphasizing this suggestion as one of the community's biggest needs; and

WHEREAS, The Mayor of Hartford held a press conference in July 2021 to voice support for welcoming Afghan refugees to Hartford, and noted that "the success of those individuals will depend on the support that we provide;" now, therefore, be it

RESOLVED, That the City of Hartford will designate an employee to operate as a liaison for organizations and groups within the city that represent and serve the city's many immigrant and refugee communities; and be it further

RESOLVED, That this designated liaison will coordinate with, and enhance communication among, the many local groups working with refugees and immigrants in the Greater Hartford area; and be it further

RESOLVED, That this designated liaison will work with members of CRIA to implement a plan on how to best achieve the goals outlined in their request for increased communication.
